Summary of Issues Submitted by Faculty Association Members During RFP Ratification, Spring 2015

Five hundred and fifty-five (555) Faculty Association members responded to the request for ratification of the Residential Faculty Policies (RFP) in Spring 2015.

The Faculty Meet and Confer Team, on behalf of the Faculty Executive Council (FEC), also asked this question: "As a member of the Faculty Association, what issues would you like the Faculty Executive Council and the Meet and Confer Team to consider during the 2015 - 2016 issue prioritization process?"

Two hundred and seventy-six (276) members provided responses. Many faculty offered multiple issues in their response, and many reiterated the importance of the unresolved issues from the last negotiation cycle.

A brief tabulation of responses is provided below<sup>1</sup> and the complete list of responses can be found on the Faculty Association's website. At this time, this summation is provided for informational purposes only. Neither FEC, nor the Meet and Confer Team, is requesting re-prioritization of the current unresolved issues or any new issues identified in this survey.

Of the 276 responses received, approximately

- 63% (174) identified Predictable Salary Advancement, including Steps and a COLA.
- 16% (45) identified Lab Loading.
- 13% (35) identified PAR, FEP, Probationary and Appointive Faculty Evaluations.
- 10% (28) identified Faculty Accountability and Overload.
- 7% (18) identified Masters of Fine Arts.
- 5% (13) identified Faculty Supervision and Compensation.
- 4% (10) identified clarity in the successor clause for the RFP.
- 4% (10) identified Healthcare and other benefits.
- 3% (7) identified Conflict Resolution.
